Card will be issued at a nominal cost of Rs. 200.00 only. Rs. 150 paid by the customer will be loaded onto the card for subsequent use

Only copies of Vehicle Registration Certificate and Driving Licence are required to be submitted Ready to Use card - Card can be used immediately after purchase

More Control.....

- Unique DriveTrack Plus Customer ID will be generated after verification
- Effective funds utilization through "Central Cash Management System" (CCMS) - CCMS acts as a central account for all transactions of the User Cards.
- Multiple Modes of CCMS Recharge Customer can load money into his CCMs account by paying cash to the dealer or through Electronic Fund Transfer (RTGS/ NEFT).
- Multiple Modes of User Card Reload The Program offers customers facility of Remote Loading on card through CCMS. Customers can also reload user cards by paying cash to the dealer.
- Quality and Quantity Checks by HPCL.
- Web-access on request (email address mandatory).
- SMS Alerts for transactions.
